PRIVACY AND COOKIE POLICY

University Tees, Inc. ("University Tees," "we" or "us") respects your privacy and is committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website located at www.universitees.com, including any associated web pages, such as order.universitytees.com (our "Websites") and our practices for collecting, using, maintaining, protecting and disclosing that information.

We have designed our Websites with parents and children in mind. We appreciate and respect our visitors' concerns for their safety when personal information is shared with us. We are committed to protecting the privacy and security of all personal information that is submitted to us. We do not sell or share any information to third parties. While we take reasonable measures to safeguard the confidential information that you provide, University Tees has no liability for the disclosure of any information that is obtained due to transmission errors or for the disclosure of any information obtained by any unauthorized acts by third parties.

This policy applies to information we collect:

- On our Websites; or
- In e-mail, text and other electronic messages between you and our Websites; or
- Through mobile and desktop applications you download from our Websites, which provide dedicated non-browser-based interaction between you and our Websites.

It does not apply to information collected by:

- us offline or through any other means, including on any other website operated by us or any third party (including our affiliates and subsidiaries); or
- any third party (including our affiliates and subsidiaries).

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, you may choose not to use our Websites. By accessing or using our Websites, you agree and consent to this privacy policy. This policy may change from time to time (see the section below entitled *Changes to our Privacy and Cookie Policy*). Any changes

or updates to the privacy policy are effective immediately upon posting to the Websites and your continued use of the Websites after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

If you wish to browse the Websites, you may generally do so anonymously. There is no need to provide any personal information while browsing our Websites. If you choose to create an account, request a quote, contact us requesting assistance (for example through a campus manager or our Websites' Live Chat feature) we may ask for personal information. This information helps us process your inquiry and provide the best service possible.

Children Under the Age of 13.

We adhere to the Children's Online Privacy Protection Act (COPPA) on our Websites as well as offline. A child's privacy is important to us. No one under age 13 may provide any personal information to or on our Websites. We do not knowingly collect personal information from children under 13. If you are under 13, do not use or provide any information on the Websites or on or through any of the features on the Websites or provide any information about yourself to us, including your name, address, telephone number, e-mail address or any screen name or user name you may use. If we learn we have collected or received personal information from a child under 13 without verification of parental consent, we will delete that information. Providing any personal information regarding a child, including the child's name and age is strictly at the parent's discretion. At any time a parent can request to review their personal information and their child's personal information that they have submitted to us. A parent may also ask to have it deleted by sending a request to contact@universtytees.com. If a visitor to the Websites is under the age of 18, they should read the privacy policy with their parents for guidance.

Information We Collect About You and How We Collect It.

We collect several types of information from and about users of our Websites, including information:

- by which you may be personally identified, such as name, postal address, e-mail address, telephone number, or any other information the Websites collect that is defined as personal or personally identifiable information under an applicable law ("personal information"); and or
- about your internet connection, the equipment you use to access our Websites and usage details.

We collect this information:

- Directly from you when you provide it to us; and/or
- Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses and information collected through cookies, web beacons and other tracking technologies.

<u>Information You Provide to Us</u>. The information we collect on or through our Websites may include:

- Information that you provide by filling in forms on our Websites, which includes, but is not limited to, information (e.g., First Name, Last Name, Email Address, Phone Number) provided at the time of creating an account, requesting a quote or requesting support, or by some other mechanism;
- Information collected when you report a problem with our Websites;
- Records and copies of your correspondence (including e-mail addresses), if you contact us; and/or
- Details of transactions you carry out through our Websites and of the fulfillment of your orders (you may be required to provide financial information before placing an order through our Websites).

Information We Collect Through Automatic Data Collection Technologies.

As you navigate through and interact with our Websites, we (or a third party designated by us) may use automatic data collection technologies to collect certain information about your equipment, browsing actions and patterns, including:

- Details of your visits to our Websites, including traffic data, location data, logs and other communication data and the resources that you access and use on the Websites.
- Information about your computer and internet connection, including your IP address, the page(s) you request, the domain name of the website from which you may link to the Websites, your computer operating system and browser type.

The information we (or a third party designated by us) collect automatically is statistical data and does not include personal information. It is stored and used for aggregate research, promotional purposes and for future site development to better understand your needs and improve our products and services, to improve our Websites and to deliver better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns and analyze certain trends and statistics related to user sessions;
- Store information about your preferences, allowing us to customize our Websites according to your individual interests;
- Speed up your searches;
- Recognize you when you return to our Websites.

The technologies we (or a third party designated by us) use for this automatic data collection may include:

- Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. Generally, we use cookies to remind us of who you are, tailor our products and services to suit your personal interests, estimate our audience size and/or analyze your visiting patterns. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Websites. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Websites.
- Web Beacons. Pages of our the Websites and our e-mails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags and single-pixel gifs) that permit University Tees, for example, to count users who have visited those pages or opened an e-mail and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

How We Use Your Information:

We may use information that we collect about you or that you provide to us, including any personal information:

- When you submit your personal information to us unless you specify otherwise, you are entered into our consumer database. You may then be added to our list to receive e-mails regarding our special promotional offers and new product introductions periodically. We will not send you junk mailings or mail that contains pop ups, only information about our products and specials that are being offered;
- To present our Websites and their contents to you;
- To provide you with information that you request from us;

- To fulfill orders for services that you may place through the Websites or for any other purpose for which you provide it;
- To provide you with notices about your account;
- To notify you about changes to our Websites or any products or services we offer or provide though it;
- In any other way we may describe when you provide the information; or
- For any other purpose with your consent.

We may also use your information to contact you about goods and services that may be of interest to you. If you do not want us to use your information in this way, please indicate as such on the submission form. For more information, see the section titled *Choices About How We Use and Disclose Your Information* below.

Disclosure of Your Information.

We may disclose aggregated, non-personal information about our users without restriction

We may disclose personal information that we collect or you provide as described in this privacy policy:

- To our subsidiaries and affiliates;
- To contractors, service providers and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them;
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution or other sale or transfer of some or all of University Tees's assets, whether as a going concern or as part of bankruptcy, liquidation or similar proceeding, in which personal information held by University Tees about our Websites' users is among the assets transferred;
- To fulfill the purpose for which you provide it;
- For any other purpose disclosed by us when you provide the information;
 or
- With your consent.

We may also disclose your personal information:

- To comply with any court order, law or legal process, including to respond to any government or regulatory request;
- To enforce or apply our Terms of Use (located at http://documents.universitytees.com/terms of use.pdf) and other agreements, including for billing and collection purposes; or
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of University Tees, our customers or others.

Choices About How We Use and Disclose Your Information.

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- Tracking Technologies and Advertising. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly.
- Communications from University Tees. If you wish to opt-out of receiving any future communication from us, including e-mail offers and updates, and would like to be removed from our database, please use the "unsubscribe" link included in the email or send your request to contact@universitytees.com. Please include the e-mail address that you originally sent to us. This opt out does not apply to information provided to University Tees as a result of a request for quote or other transaction.

Data Security.

We have implemented reasonable security measures designed to secure the personal information under our control from accidental loss and from unauthorized access, use, alteration and disclosure.
